Their email addresses are shown on the email already sent to you. The deadline date for submission is contained within the email you have received.

The final date for submission is strictly adhered to so as to ensure that all companions are treated equally in terms of the time available to complete submissions and for a full evaluation of those nominated.

It is vital that you take time to check the details on the form particularly in respect of dates, and offices, plus aspects of activities outside the Chapter of which the Scribe E may be unaware.
