# CRITERIA FOR THE GUIDANCE OF THE VSO

#### PROPOSING A NOMINEE FOR APPOINTMENT TO PAST PROVINCIAL GRAND STEWARD.

Appointment to Provincial Grand Rank is the sole prerogative of the Grand Superintendent. He may confer any Provincial Grand Rank he deems appropriate from those detailed in the Book of Constitutions on any member of a Lodge within the Province.

- No member has any prescriptive right to Provincial Grand Rank.
- The rank of a Past Provincial Grand Steward is considered special and is for those
  companions who have not been and do not wish to progress through the office of 1st
  Principal of their Chapter, and have given exceptional service to the Chapter, perhaps in
  a Regular Office and/or given notable service and support to their Chapter or Masonic
  Hall.
- The appointment is based on the quality of the contribution the Companion has made to his Chapter, Hall, District, Area, and the Province or to Royal Arch Masonry and society in general and in anticipation of his ability to contribute further in the future.
- The companion must have been a member of the Chapter for at least **10 years** and have attended the Chapter regularly.

<u>This form's sections should be completed with complete fairness and honesty for the nominee's entitlement to a Provincial Honour.</u>
