## CRITERIA FOR THE GUIDANCE OF THE VSO

## PROPOSING A NOMINEE FOR APPOINTMENT PAST PROVINCIAL GRAND PURSUIVANT

Appointment to Provincial Grand Rank is the sole prerogative of The Provincial Grand Master. He may confer any Provincial Grand Rank he deems appropriate from those detailed in the Book of Constitutions on any member of a Lodge within the Province.

- No member has any prescriptive right to Provincial Grand Rank.
- The rank of a Past Provincial Grand Pursuivant is considered special and is for those Brethren who have not been and do not wish to progress to the Chair of their Lodge, has been a member for at least **15 years** and has given exceptional service to the Lodge, perhaps in a Regular Office and/or given notable service and support to their Lodge or Masonic Hall.
- The appointment is based on the quality of the contribution the Brother has made to his Lodge, Hall, District, Area, and the Province or to Freemasonry and society in general and in anticipation of his ability to contribute further in the future.
- Has attended the Lodge regularly over the above period of time.

This form's sections should be completed with complete fairness and honesty for the nominee's entitlement to a Provincial Honour.
